Introductions of all members were made.

Meeting was called to order at 11:55 a.m. by Kathi A. Previous Board Meeting Minutes were reviewed and accepted.

Announcement- Sadly, Julie Banks' father passed away and she has resigned as a board member. Kathy Albanese contacted Sandy Champlin and asked her to take place of Julie on the board. Sandy has accepted the position.

Area VII show Committee had their meeting yesterday, November 26, 2010. Kathy requested that one PCMHC officer attend all Area VII show meetings. Cathy Brubaker will be asked to judge the Area VII show. Roger Eitel will be asked to judge the April 23rd, 2011 PCMHC.

Treasurer's report- Wendy Anderson submitted the financial report for the entire show season.

PCMHC 2011 Membership fees were discussed. All members of the board agreed to increase individual membership to \$25, \$40 for family and \$15 for youth. Add an additional adult to family membership is \$15.

Tasks were discussed and divided amongst the board members.

PCMHC Membership Cards will be issued to all members for year 2011. A copy of this card is required with all entry forms for each show. These cards maybe presented to retail stores in Norco and surrounding areas and PCMHC members could receive discounts of up to 10% on feed and/or merchandise.

High Point Nomination fees of \$10. shall remain the same. All sponsorship fees become part of a pool of money that will then be put towards year end awards. It is important to remember that the nomination fees do not cover the cost of year end awards. We need every member to sponsor or seek sponsorship for as many classes as possible. This will help the club provide awards that the recipient and the club can be proud of.

2011 PCMHC Advertising fee remain the same for website, featured farm and classified ads.

2011 PCMHC Sponsorship was discussed and tabled until next meeting.

Show premium design was discussed, minimal changes were made and included was noticed that **"PRE ENTRY ONLY FLAT RATE FEE OF \$80."** The new logo was voted in and accepted as part of 2011 show premium. All show fees reviewed and approved.

Additional performance classes were discussed voted on and accepted and goes as follows:

Jumper and Versatility will be offered to Youth, Amateur and Open in both "A" and "B" height divisions.

Hunter and Halter Obstacle will be offered to Amateur in both "A" and "B" height divisions.

Class line up was discussed with consideration of 16 additional classes and warm up times.
