Show Start Time

Show will begin promptly at 8:00 am each day.

Refunds

Refunds will be given only upon receipt of a veterinarian certificate. There will be **NO REFUNDS FOR STALL FEES**

Ring Procedure

Management shall expect all ASPC/AMHR exhibitors to have familiarized themselves with the official rule book of the ASPC/AMHR. Any horse that becomes a threat to an exhibitor, audience or other animal may be asked to be removed from the show grounds.

Two Minute Gate Rule

Once the class is called, the gate steward will begin timing for all entries to enter. There will be no refund for missed classes. It shall be the exhibitor's responsibility to watch the progression of the show.

Gate Holds

Gate holds must be given to the gate steward 5 classes in advance. Gate holds will be for a maximum of 2 minutes. 5 minutes for harness changes.

Lunch and Breaks Shall be called at the discretion of the Judge and/or Show Management.

Class Changes

Any and all class changes must be done in the show office

Liberty Class

All entries in liberty classes must bring their own music. Music must be cued to where you wish it to begin. All AMHR rules regarding liberty will apply.

Scratched Entries

All scratched horses must have a veterinary certificate to receive any and all refunds. It is the responsibility of the exhibitor or their representative to notify the show office of the class to be scratched and complete a refund request form in order to obtain a refund. Refunds will be mailed to the exhibitor after the conclusion of the show. Failure to show a horse that is entered constitutes a forfeiture of all entry fees.

Measuring Start Time

Thursday – May 21 – 1:00pm – 7:00 pm May 22-24, 6:30 am – 9:00 am (as needed and Steward is available)

If your horse has a permanent card, bring it with you. If you post enter your horse, bring two copies of the registration, one for the show manager and one for the show steward. **NOTE: The show steward will be in the ring and will not be available to measure during in hand performance classes Please plan accordingly.**

Amateur Classes

The exhibitor must have a current year Amateur Card, exhibitor must be 18 or older as of December 1, 2025 For all **AMHR only** Amateur Classes, you must be the registered owner/lessee of the horse before you or a member of your family can show in an amateur class.

Youth Classes

Youth must be under 18 on December 1, 2025. An AMHR youth card is optional. Youth 13 years of age or older may show a stallion. Youth showing without a Youth membership will not have placings or points recorded by the national office nor are they eligible for any ASPC/AMHR/ASPR Youth High Point or other awards.

Headers

Headers must be 16 years old or older, and are required in all youth driving classes. Headers are to enter the ring when the line-up is called. Headers are optional in all other non-youth driving classes. Appropriate dress must be maintained in the show ring, this means no shorts, tank tops, T-shirts or clothing with logos on them.

Roadster

All youth **MUST** wear protective head gear (Certified ASTM/SEI) in roadster classes. Headgear harness must be secured and properly fitted. Youth **may** wear protective head gear in other driving classes.

Championship Classes All championship classes must be reworked and judged as a new class, therefore if you have more than one horse in a championship class please have additional handlers available in advance and ready when the class is called.

Disclaimer

Every entry at a PCMHC show sanctioned by the ASPC/AMHR/ASPR shall constitute agreement that all participants:

- a. Shall be subject to the rules of the ASPC/AMHR/ASPR and PCMHC
- b. Every animal and exhibitor is eligible as entered.
- c. Agree to be bound by the rules of the ASPC/AMHR/ASPR and PCMHC and accept as final any ASPC/AMHR/ASPR PCMHC, their official directors and employees harmless for any action taken.
- d. Agree that they participate voluntarily in the competition fully and are aware that equine sports and the competition involve inherent dangerous risks and by participating they expressly assume all risks of injury or loss during or in connection with the competition whether or not such injury or results, directly or indirectly, from negligent acts or omissions of said officials, directors, employees and agents of the ASPC/AMHR/ASPR, PCMHC or the competition.

entries into the National Futurity Program. Futurity classes are **NON RATED** – you may cross enter your AMHR horse into ASPC futurity classes, provided they were sustained with the ASPC/AMHR National Futurity Program. Payout will be based on a points system and prize money will be paid only after all area futurities are completed for the year.

Gelding Incentive Classes

The ASPR/AMHR conducts a Gelding Incentive Program offering cash prizes for entries in special Amateur Gelding Incentive classes. The incentives are specific classes and are separate from other ASPC/AMHR approved classes. No All-Star points are awarded in the incentive classes. Monetary awards will be determined based on funding from the ASPC/AMHR. All Area Shows will be funded identically with money being identical in each incentive class. All leases on horses/ponies used in Amateur Incentive classes must be recorded, processed and completed through the Registry prior to December 31st of the current show year. **If a lease is processed and completed after January 1st, the amateur cannot participate in any amateur incentive class with that horse/pony.**

****Open Classes** - Open classes are non rated and open for any miniature, pony, and mule/donkey to enter. Horses do not need to be registered to enter but are NOT allowed to cross enter between an Open class and any AMHR/ASPC/ASPR rated class. Class #112 Reinsmanship Driving may cross enter with either registered or unregistered horses. Open classes will follow the AMHR/ASPC standards and rules.
